- 1. <u>Call to Order</u> President Kwon called the meeting to order at 1:37 PM.
- 2. Roll Call

Present: Kwon, Courtney, Caen, and Moran Excused: Vietor

President Kwon announced that Closed Session items 16 through 21 would not be heard.

3. <u>Approval of the Minutes of May 8, 2018</u> On Motion to approve the Minutes of May 8, 2018: Ayes: Kwon, Courtney, Caen, and Moran

- 4. General Public Comment
 - Chris Shutes, California Sport Fishing Protection Alliance, discussed an amendment to the Appropriations Bill as offered by Mr. Valadao of California, restricting funds as related to sections 10 and 18 of the Federal Power Act as related to the Don Pedro and La Grange hydroelectric projects along the Tuolumne River. He stated a letter in opposition was submitted to the subcommittee. Copies of the amendment and letter were provided to the Commission Secretary. He asked that the Commission prepare a resolution in opposition to the amendment and the item be agendize.
 - Peter Drekmeier, Tuolumne River Trust, discussed the proposed amendment. He reviewed a study regarding San Franciscans' opinion of the environment and their support for water diversification for environmental support. He asked that the Commission prepare a resolution in opposition to the amendment and the item be agendize.
 - Cindy Charles, Golden West Women Fly Fishers, discussed her participation in the Don Pedro and LaGrange relicensing and the proposed amendment. She expressed opposition to the proposed amendment and asked that the Commission prepare a resolution in opposition to the amendment and the item be agendize.
 - Ann Clark, Friends of Camp Mather, thanked Commission for their work related to Camp Mather. She expressed appreciation for the opportunity to have John O'Connell students at the Camp. She stated the Camp Mather friends and family event will be held on September 26th. She complemented SFPUC water inspector Matthew J. Brady for his professionalism during a visit to her home to inspect for leaks.

Ms. Clark responded to a question from Commissioner Caen regarding the opening date for Camp Mather.

• Barry Nelson, Golden Gate Salmon Association, discussed the proposed amendment. He reviewed the Salmon Association's role and noted the importance of the Bay Delta for the salmon industry and the need for salmon protection and management. He asked that the Commission prepare a resolution in opposition to the amendment and the item be agendize.

 - Steve Ritchie, Assistant General Manager (AGM) Water, responded to a question from Commissioner Caen regarding the snow pack levels, indicating the system will fill with the run-off and that the water bank is full.

6. Other Commission Business

Commissioner Caen read from an April 17, 2018 San Francisco Chronicle article regarding the 1958 Giants debut. The article noted the Commission covered 29 items in less than an hour so Commissioners could attend the game.

Vice President (VP) Courtney) thanked staff and all involved with the Golden Pride Award ceremony and he complemented the good quality of the video production.

7. Report of the General Manager (GM)

a) CleanPowerSF (CPSF) Update

Barbara Hale, Assistant General Manager (AGM) Power, provided a CPSF update: (1) <u>Enrollment</u>: Serving 81,000 accounts; 3.2% opt-out rate; 4.2% SuperGreen upgrade rate; July enrollment notices being mailed which will increase the customer count to approximately 105,000, with the addition of mostly commercial accounts; (2) <u>Regulatory</u>: Exit Fee hearings at the California PUC (CPUC) have concluded and SFPUC is working with the City Attorney and trade association on the preparation of a brief which is due in June. Proposed decision to be published for comment is anticipated in August; and (3) <u>Customer Choice Report</u>: Report (Green Book) has been published. SFPUC staff will meet with CPUC staff to discuss the report.

 b) <u>Hetch Hetchy Capital Improvement Program (CIP) Quarterly Report</u> Dan Wade, Director, Water Capital Projects and Programs, provided the Hetch Hetchy Water Enterprise CIP quarterly report: (1) March 22, 2018 storm event at Moccasin with review of post-event actions; (2) Next steps; (3) Mountain Tunnel interim repairs; (4) Mountain Tunnel rehabilitation; (5) New shops and office at Moccasin; and (6) Moccasin Penstock rehabilitation cancelled due to the Moccasin emergency.

Director Wade responded to a question from Commissioner Moran as to the meaning of "interim" repairs at Mountain Tunnel. GM Kelly provided additional response.

- c) Quarterly Audit and Performance Review Report

Nancy Hom, Deputy Chief Financial Officer (CFO), presented the quarterly Audit and Performance Review Report. She indicated there have been 37 audits and assessments year-to-date, with 16 completed, 12 in-progress, and nine upcoming. She noted the four audits listed above have been completed. Deputy CFO Hom reviewed the Sewer System Improvement Program (SSIP) planning and pre-construction activities audit highlights, audit objectives, recommendation summary, and conclusions.

She discussed the completed performance audits (Citywide Fleet Management Audit and the Annual Physical Inventory Count, FY 2016-17), and upcoming audits. Ms. Hom concluded with a review of prior years open City Services audits and recommendations (15 total with three open and 12 closed, for a completion rate of 80%).

Commissioner Moran questioned the reasons for prior year audits still being open. Ms. Hom explained that other agencies are determined be the lead and are responsible for the of audit recommendations and resolution. She explained the SFPUC's specific responsibility for response for those audits.

Commissioner Moran reminded Ms. Hom of the Commission's request that open audits should be closed within six months, and if that was unlikely, a schedule of objectives and a timeline for response should be established and brought to the Commission for approval. He noted the current reporting is good, but follow-up needs to be implemented to ensure closure.

Deputy CFO Hom responded to a question from Commissioner Moran regarding the status of previously reported Inventory Count/Control Audit which indicated the need for a subsequent review of residual issues and the need for the development and implementation of information system tracking in Maximo. Ms. Hom indicated she will look at the recommendations and report back.

Commissioner Moran discussed the importance of the SSIP audit so that customers know the program is properly managed. He mentioned the Wholesale Revenue Requirement report, specifically the review of analysis report and the inadvertent charge to water for power items. Ms. Hom briefly discussed the review analysis. No public comment.

d) Quarterly Budget Status Report

Eric Sandler, AGM Business Services and CFO, stated there are positive net results projected for all operations. He reviewed the following: (1) Observations: Water and Wastewater, and CleanPowerSF higher revenues; Power lower revenues as compared to budget; Financial results meet policy targets for coverage and reserves; (2) FY 2018 Water budgetary variances increased water sales revenues and cost savings: Sources \$51.2M or 10.2% higher revenues due to increased water sales; Uses \$1.6M or 0.3% savings from general reserves; (3) FY 2018 Wastewater budgetary variances increased wastewater revenues and cost savings: Sources \$10.3M or 3.4% higher revenues due to billed volumes; Uses \$46.5M or 15.1% savings from general reserves and reduced expenses; (4) FY 2018 Power budgetary variances reduced power sales revenue offset by cost savings: Sources \$(19.3M) or 9.8% lower than budget due to lower power sales; Uses \$26.0M or 12.85% savings from reduced expenses; (5) FY 2018 CleanPowerSF budgetary variances sales revenues above budget and use cost savings; Sources \$0.5M or 1.2% higher; Uses: \$1.0M savings from reduced expenses; and (6) Key Financial Ratios: fund balance reserve (25%-68% of annual operating uses); debt service coverage reserve; and CleanPowerSF reserve target is projected to be met.

Commissioner Moran noted the retail water revenue surplus. He asked if there are any funding opportunities available for water conservation capital and/or incentive programs. CFO Sandler stated staff will review opportunities and report back via memo on findings.

No public comment.

e) New Employee Orientation Procedures

GM Kelly mentioned Assembly Bill (AB) 119 which impacts new employee orientation (NEO) and union access. GM Kelly introduced Cindy Charan, Director of SFPUC Human Resources, who provided context on AB 119, discussed the outcome of citywide negotiations, and reviewed enhancements to the SFPUC NEO. She noted unions will now be allowed 30 minutes access during NEO (expanded from 10 minutes). She discussed two changes included in AB 119: (1) 10 business day notice to the unions of the NEO; and (2) Providing the union with employee name, job title, department, work location information, home, work and personal cell phone information, and personal email.

Director Charan outlined additional steps the SFPUC will take with union partners regarding NEO: (1) NEO calendar invitations sent to union representatives, with relative information and documents included; and (2) Creation of form for employees identifying employee's union organization, union representative contact information, and weblink to union's homepage. VP Courtney thanked Director Charan, her staff, and the City Attorney for their work. He provided comments regarding AB 119, the importance of the NEO improved practices, and the need to share SFPUC practices with other city departments.

f) <u>Report on Recent San Francisco Public Utilities Commission Activities,</u> <u>Events and Announcements</u> <u>GM Kelly thanked staff for the organization of the Golden Pride Award event.</u> He asked the Commission for feedback for possible improvement.

 Bay Area Water Supply and Conservation Agency (BAWSCA) Update Nicole Sandkulla, BAWSCA CEO, provided her monthly update: (1) <u>Making</u> <u>conservation a way of life</u>: AB 1668 and SB 606 companion bills for long term water use targets for water suppliers; (2) <u>Strategic Plan Goals</u>: Access capabilities, state policy, and inform BAWSCA work plan; (3) <u>Elements of Key</u> <u>Concern</u>: Outdoor water use, commercial and industrial water use, and water loss; and (4) <u>BAWSCA FY 2018-19 Work Plan</u>: Actions to support compliance with legislative requirements

CEO Sandkulla indicated BAWSCA's March 2018 total potable water use was 21% less than during March 2013.
