**CEQA Appeal Rights under Chapter 31 of the San Francisco Administrative Code**: If the Commission's action on a project constitutes the Approval Action for that project (as defined in S.F. Administrative Code Chapter 31, as amended, Board of Supervisors Ordinance Number 161-13), then the CEQA determination prepared in support of that Approval Action is thereafter subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16. Typically, an appeal must be filed within 30 calendar days of the Approval Action for a project that has received an exemption or negative declaration pursuant to CEQA. For information on filing an appeal under Chapter 31, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call (415) 554-5184. If the Planning Department's Environmental Review Officer has deemed a project to be exempt from further environmental review, an exemption determination has been prepared and can be obtained on-line at http://www.sf-planning.org/index.aspx?page=3447</u>.Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or in written correspondence delivered to the Board of Supervisors, Planning Commission, Planning Department or San Francisco Public Utilities Commission at, or prior to, such hearing, or as part of the appeal hearing process on the CEQA decision.

### **CONSENT CALENDAR**

9. All matters listed hereunder constitute a Consent Calendar, are considered to be routine by the San Francisco Public Utilities Commission and will be acted upon by a single vote of the Commission. - a) Approve an increase of 547 consecutive calendar days (approximately 18 months) to the existing contract duration contingency for <u>Contract No. WD-</u>2621R, San Francisco Groundwater Supply Well Stations; and authorize the General Manager to approve future modifications to the contract for a total revised contract duration of up to 1,934 consecutive calendar days (approximately five years and four months), with no change in the contract amount. - b) Accept work performed by JDB and Sons Construction, Inc. for <u>Contract</u> <u>No. WD-2832</u>, Sunol Nursery; approve Modification No.19 (Final) decreasing the contract amount by \$83,969, for a total contract amount of \$2,220,092, and increasing the contract duration by 317 consecutive calendar days (approximately 10 and one-half months), for a total duration of 737 consecutive calendar days (approximately two years and one month); and authorize final payment to the contractor.
