**CEQA Appeal Rights under Chapter 31 of the San Francisco Administrative Code**: If the Commission's action on a project constitutes the Approval Action for that project (as defined in S.F. Administrative Code Chapter 31, as amended, Board of Supervisors Ordinance Number 161-13), then the CEQA determination prepared in support of that Approval Action is thereafter subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16. Typically, an appeal must be filed within 30 calendar days of the Approval Action for a project that has received an exemption or negative declaration pursuant to CEQA. For information on filing an appeal under Chapter 31, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call (415) 554-5184. If the Planning Department's Environmental Review Officer has deemed a project to be exempt from further environmental review, an exemption determination has been prepared and can be obtained on-line at <a href="http://www.sf-planning.org/index.aspx?page=3447">http://www.sf-planning.org/index.aspx?page=3447</a>. ### **CONSENT CALENDAR**

- 9. All matters listed hereunder constitute a Consent Calendar, are considered to be routine by the San Francisco Public Utilities Commission and will be acted upon by a single vote of the Commission. There will be no separate discussion of these items unless a member of the Commission or the public so requests, in which event the matter will be removed from the Calendar and considered as a separate item.
  - a) Approve execution of an <u>Attestation of Veracity</u> for the San Francisco Public Utilities Commission's CleanPowerSF Program 2019 Power Source Disclosure (PSD) Report and submission of that Report to the California Energy Commission. CleanPowerSF is required by State law to annually disclose the sources of electricity generation used to serve its end-use electric customers. For Green customers, the percentage of supply attributable to renewable energy resources was 48.1% and for SuperGreen customers, renewable energy resources comprised 100% of the supply portfolio. - b) Approve execution of an <u>Attestation of Veracity</u> for the San Francisco Public Utilities Commission's Hetch Hetchy Power 2019 Power Source Disclosure (PSD) Report and submission of that Report to the California Energy Commission; and authorize the General Manager to make necessary changes to the Report. Hetch Hetchy Power is required by State law to annually disclose the sources of electricity generation used to serve Hetch Hetchy Power's end-use electric customers. The electricity sources used to serve Hetch Hetchy Power's end-use electric customers were 100% greenhouse-gas free and Hetch Hetchy Power met its compliance obligations under California's Renewable Portfolio Standard. (Hale)
- c) Approve the plans and specifications, and award <u>Contract No. WW-706</u>, Oceanside Water Pollution Control Plant Egg-Shaped Digester Interior Liner Rehabilitation, in the amount of \$2,461,000, and with a duration of 720 consecutive calendar days (approximately two years), to the responsible bidder submitting the lowest responsive bid, Trinet Construction Inc., to remove defective and failed interior liner system materials within Egg-Shaped Digesters Nos. 1, 2 & 4 and apply new liner system along with selective mechanical valves and associated process piping at the Oceanside Water Pollution Control Plant. (How)

### **REGULAR CALENDAR**

- 10. Adopt a finding declaring as surplus to its utility needs, approximately 16 acres of property (Property) owned by the City and County of San Francisco (City), under the jurisdiction of the San Francisco Public Utilities Commission, in San Francisco, California, commonly known as the Balboa Reservoir (portion of Assessor's Block 3180, Lot 190); Consent to the **Balboa Reservoir Development Agreement** with Reservoir Community Partners, LLC (Developer); Adopt findings pursuant to the California Environmental Quality Act and a Mitigation and Monitoring and Reporting Program; Approve the terms and conditions of and recommend to the Board of Supervisors the authorization of the General Manager to sign: (i) an Agreement for Sale of Real Estate relating to the Property to the Developer for \$11,400,000; (ii) a Recognition Agreement recognizing performance, cure, and reassignment rights between the master co-developers of the project; (iii) a Promissory Note and a Deed of Trust securing complete payment of the purchase price; (iv) a Declaration of Restrictions to be recorded against City property allowing a portion of such property to be used as dedicated public right-of-way for the planned extension of Lee Avenue, and (v) a 20-year Open Space License with the Developer for use of an approximately 44,431 square-foot area south of the Property with either (i) a \$112,000 lump-sum use fee payable at the commencement of the License term or (ii) an annual use fee in the initial amount of \$32,380 commencing after the tenth year of the term, with 4% annual use fee increases; and Approve the terms and conditions of, and recommend to the Board of Supervisors the authorization of City's Director of Property to sign, an Amended and Restated Access Easement Agreement and Deed with City College. (Carlin)
- 11. Approve Amendment No. 3 to <u>Agreement No. CS-204</u>, Fish Passage Facilities, within the Alameda Creek Watershed, a sub-project of the Calaveras Dam Replacement Project, with URS Corporation; and authorize the General Manager to execute Amendment No. 3, increasing the agreement amount by \$400,000, and extending the

agreement duration by nine months, for a total not-to-exceed agreement amount of \$5,164,580 and a total agreement duration of nine years and four months. (How)

- 12. Confirm and clarify existing Commission policy that CleanPowerSF will not procure specified sources of nuclear energy as part of its energy portfolio to serve its retail customers. <u>CleanPowerSF's Product Content Policy</u> adopted by the Commission in Resolution No. 15-0267 and reaffirmed in Ordinance 18-08 by the Board of Supervisors prohibits the specified purchase of nuclear power for the purposes of firming and shaping the electricity portfolio used to serve CleanPowerSF customers. (Hale)
- 13. Approve the terms and conditions of, and authorize the General Manager to seek approval by the Board of Supervisors and Mayor to execute, the <u>First Amendment to</u> <u>the deed</u> dated April 6, 1907 (Original Deed) between the Koret Foundation and City, for the purpose of clarifying and amending the respective rights of the parties to the Original Deed with respect to SFPUC Parcel 22 located between West Orange Avenue and Southwood Drive in South San Francisco, California. (Carlin)
- 14. Discussion and possible action to adopt a resolution directing San Francisco Public Utilities Commission staff to work with the Modesto Irrigation District and Turlock Irrigation District on an agreement for early implementation of the proposed <u>Tuolumne River Voluntary Agreement</u> (TRVA) upon submittal of the TRVA to the State Water Resources Control Board for analysis as an alternative to a portion of the December 12, 2018 Phase 1 Amendments to the Water Quality Control Plan for the San Francisco Bay-Sacramento/San Joaquin Delta Estuary. (Ritchie)
- 15. Approve the <u>Water Supply Assessment</u> for the proposed 900 7<sup>th</sup> Street Project, which would construct up to 1.27 million gross square feet of mixed-use space, including residential, office, laboratory and/or life science, production, distribution, and repair uses at the site of an existing Recology facility in San Francisco, pursuant to the State of California Water Code Section 10910 *et seq.*, California Environmental Quality Act (CEQA) Section 21151.9, and CEQA Guidelines Section 15155.
