 - threat of erosion to the Oceanside Treatment Plant and its associated infrastructure from Ocean Beach
 - o efforts to prevent further erosion at Ocean Beach
 - upgrade to the Westside Pump Station requiring an increase in the infrastructure footprint which is problematic because the upgrade is going to encrouch on restoration efforts.

Discussion Topics:

• *Member Nagengast* asked if more people leave the program after the first year or after the second year, and what are their reasons for leaving.

Lopez-Weaver confirmed they don't have a huge turnover for people leaving the program.

• *Member Nagengast* also asked why firms such as Jacobs are not committing for a three-year time frame for one intern, and why there is no continuity.

Lopez-Weaver confirms Jacobs actually hosts three interns and has done so for the past three summers.

Staff Zhu replied that the number of interns that SSIP Cityworks brings on each summer is between 15 and 22 and that 16 is a good size cohort for one program manager.

- Member Mckinney asked, out of all the active contracts that have community benefits clauses included in their contract, how many are committed to doing internships for the students.
 Staff Zhu referred back to list of firms Lindsey included in presentation.
- *Member McKinney* asked when firms are contracted with the SFPUC to perform work as a part of the Sewer System Improvement Program (SSIP), over what timeframe must they engage in community benefits. *Staff Zhu* confirmed it is during their contract term.
- *Member McKinney* asked how many firms are nearing the end of their contract.

Staff Zhu listed several firms but would need to double check on the complete list.

- *Member Nagengast* encouraged Lopez-Weaver to do end of summer debriefs with the company sponsors and Cityworks interns to see what they liked and how the internship could be improved. *Lopez-Weaver* indicated that after each summer, the firms come together to provide feedback for the program.
- Member Mckinney asked if Lopez-Weaver is looking to have the alumni be mentors for incoming interns. Lopez-Weaver replied yes.
