The Citizens Advisory Committee provides recommendations to the San Francisco Public Utilities Commission General Manager and the Board of Supervisors regarding the agency's long-term strategic, financial, and capital improvement plans.

A survey was conducted to assess how well the committee members and supporting staff are functioning, the favorite topics presented in 2015, and the priorities for 2016. The survey was conducted using Survey Monkey from January to February of 2016, in which all 16 members provided feedback.






#### Why did you seek appointment to the SFPUC CAC and what do you hope to accomplish?


All responses fell into three main categories:





#### **Evaluation Summary:**


- A majority of members felt very engaged at the CAC meetings.

#### How engaged do you feel as CAC meetings?



#### How supported do you feel by CAC Leadership?




#### How supported do you feel by CAC Staff?
