- 3. Report from the Chair
 - Chair welcomes committee members, staff, and the public
- Public Comment: Members of the public may address the Committee on matters that are within the Committee's jurisdiction and are not on today's agenda
 - Steve Lawrence provided a detailed message regarding protecting infrastructure at South Ocean Beach.
 - He suggested the protection of the Lake Merced Tunnel, which stores millions of gallons of storm water so that the Oceanside Plant is not swamped, as well as the Westside Transport Box and the plant itself, are awfully important.
 - Storms threaten or eat away at the cliffs--quickly. Not frequently, but when waves do, they erode soils fast. One big storm and protection (Earth) could be gone.
 - Lawrence believes that while the CAC should learn about what effect that would have, it's possible that this could shut down the plant, and it certainly could undermine how the plant is designed to work.
 - We live with risk; so far, we're lucky. There are plans to protect, and also to remove what now constitutes some protection--ugly rock and concrete that mars the beauty and wildness of the beach.
 - The CAC should learn about the risks and effects if those eventuate and should learn about the plans and schedule for interim and permanent protection. When will rock and rubble come off?

Discussion Topics:

• *Member Kott* inquired whether the team tries to work together with the City Sea Level Rise Coordinating Committee.

Benson replied there is an interdepartmental effort that started with a seal level rise action plan that started two years ago. Each department has been doing the work of looking at assets and potential risks to those assets.

 Member Ekanem asked who is taking the lead on the southern part mission creek.

Benson answered that's port jurisdiction, so the port is taking the lead as to the army corps study. They just signed the agreement with the corp. Regarding the three million dollars for that study, half is federal, and the other half is coming from the port.

- Member Kott asked if anything comes from the state.
 Benson responded no, not for this study.
- Staff Zhu asked if it would it be helpful to define what the port iurisdiction is.

Benson answered that anything west and south of Fisherman's Wharf is someone else's jurisdiction.

- Member Loewenberg questioned where Benson sees the first phase of work happening and why there.
 - Benson answered that his team needs to prioritize getting the multihazard risk assessment complete first. They want to be informed by the damage assessment. They are extremely concerned for life safety, and access for first responders.
- Member Nagengast inquired how Benson and his team got to 425 million.
 - Benson replied they are operating within the fiscal constraints of the city. They did a lot of consultation with the city's Capital Planning Committee, and the city manages its GO bond program in a very particular way. There was more than 425 million dollars within that available bonding capacity, but that's what the committee approved as a conservative move for the seawall because it's the first time this kind of work is being funded in the city's capital GO bond schedule.
- Member Nagengast asked how a homeowner, renter, or someone else in the city is impacted.
 Benson answered daily, it won't affect anyone. Tax rates stay the

- Member Thomas stated that she doesn't feel like she has a good understanding of what the overall priorities of the SFPUC are. Staff Zhu answered that historically the agency has not done a good job of saying exactly what their top priorities are. This is a good question to ask to push the leader to be able to articulate that. In the past, the CAC has had the General Manager come and present on the priorities of the agency. Perhaps staff needs to prioritize scheduling another General Manager address to the CAC.
- Member Ekanem recommended there be one place where members can find the laundry list the General Manager gives us every year.
 Staff Zhu agreed and suggested we get Harlan back on the agenda soon.
