1. Call to Order

President Moran called the meeting to order at 1:33PM.

2. Roll Call

4. General Public Comment

- Mr. Francisco DaCosta discussed his visit to the Dakota Pipeline; addressed recent odor issue with SFPUC; water and king tides.
- Mr. Alvin Ja distributed a letter regarding Balboa Reservoir and discussed the Reservoir Report. He addressed affordable housing on the site.
- Mr. Peter Drekmeier, Tuolumne River Trust, provided a handout to the Commission. He discussed the need to the Bay Delta Plan on the agenda so comments can be heard. He expressed concerns with staff and information provided on a SFPUC brief. He submitted a Sunshine Request.

President Moran urged those interested in SWRCB issues to read the Annual Report.

AGM Hale responded to a question from Commissioner Vietor regarding the Departmental Greenhouse Gas Emissions Report (5h) and the status of the conversion of the vehicle fleet to GHG-Free.

No public comment.

6. Other Commission Business

Commissioner Caen indicated she adopted a drain and encouraged everyone to do the same.

Commissioner Courtney discussed the Public Works apprentice who was killed. He spoke about the need for workforce development and transparency; and discussed how workforce development relates to community benefits in the public v. private sectors. He requested that President Moran agendize Workforce Development. He expressed concerns regarding work with non-profits and requested that guidelines be developed.

President Moran asked staff to work, through the General Manager, with Commissioner Courtney to agendize his issues.

7. Report of the General Manager

a) Drought Update

Mr. Steve Ritchie, Assistant General Manager (AGM) Water, provided a drought update. He reviewed state drought levels (U.S. Drought Monitor), and responded to a question from President Moran on how the Drought Monitor gathers information. He reviewed total system storage; Cumulative precipitation; Precipitation forecast; Snowpack; Tuolumne River water available to the City; and total deliveries.

No public comment.

b) CleanPowerSF Update

Ms. Barbara Hale, AGM Power, provided a CleanPowerSF update. She indicated customers in Districts 5, 8, and 10 are being served. The Program has 7,800 accounts; an opt-out rate of two percent; and 1,609 SuperGreen upgrades. She stated 496 customers have enrolled for the next offering, with 79 upgrades.

Ms. Hale discussed PG&E's rate adjustments, stating the California Public Utilities Commission (CPUC) will be issuing a decision on PG&E's rate requests, which are to be effective January 1st. She indicated the impact on Hetch Hetchy customers will be small and revenue neutral. She anticipates another PG&E rate adjustment in April or May. She emphasized that

CleanPowerSF rates are not changing, but rather that PG&E is changing the factors that they bill CleanPowerSF customers (PCIA), and projects a five percent higher bill. She stated that SFPUC comments have been filed with the CPUC.

AGM Hale responded to a comment from Commissioner Vietor regarding the need to communicate information to customers regarding the bill increase.

c) Quarterly Budget Status Report

Mr. Eric Sandler, CFO and AGM Business Services, provided a quarterly budget status report. He discussed: (1) Observations: Water and Wastewater higher revenues, and Power lower revenues; (2) FY 2017 Water budgetary variances: increased water sales revenues and uses cost savings (sources and uses); (3) FY 2017 Wastewater budgetary variances: increased wastewater revenues and uses cost savings (sources and uses); (4) FY 2017 Power budgetary variances: reduced power sales revenue offset by cost savings (sources and uses); (5) FY 2017 CleanPowerSF budgetary variances: sales revenues on target, uses cost savings (sources and uses); and (6) Key reserves ratios.

Public Comment

 Mr. Francisco DaCosta expressed concern with the use of clean drinking water for construction and toilet flushing.

d) SFPUC Policies Review - Proposed Schedule

CFO Sandler presented the proposed schedule for upcoming policy review.

President Moran provided comments on the Fund Balance Reserves Policy and Framework for Land Management and Use Policy. He stated he would like to add a Workforce Development and Retention Policy

No public comment.

e) <u>Hetch Hetchy Water and Power (HHWP) Capital Improvement Program (CIP) Quarterly Report</u>

Mr. Dan Wade, Director of Water Capital Programs and Projects, presented the HHWP CIP quarterly report. He discussed: (1) Upcoming Mountain Tunnel shut-down; (2) Adit improvements; (3) Re-baselining of "red dot" programs: (San Joaquin Pipeline rehabilitation; Holm Powerhouse Unit 2; and Cherry Dam Outlets rehabilitation); (4) Forecast schedule delays (San Joaquin Pipeline rehabilitation; Lower Cherry Aqueduct; and Mountain

Tunnel inspection repairs). Mr. Wade concluded with an update on the Rim Fire.

Mr. Wade responded to a question from Commissioner Caen regarding the overall amount the WSIP is over-budget.

- g) <u>Sewer System Improvement Program (SSIP) Update</u>

 Ms. Karen Kubick, Wastewater Enterprise Capital Program Director, SSIP, presented the CIP quarterly report and a SSIP update.

She stated the SSIP has three projects with six months or more delay: (1) Digester Gas Handling Project; (2) Kansan Marin Street Sewer Improvements; and (3) Land Reuse 1801 Jerrold.

Ms. Kubick provided a SSIP Program Status, noting 14 percent of Phase 1 projects are complete, with most projects in planning and design. She reviewed a program status timeline; noted current construction projects: (SEP and OSP; and EIP's).

Ms. Kubick provided updates on major Phase 1 projects: (1) Headworks \$385M; and (2) Biosolids \$1.276M. She outlined project achievements; provided a SSIP Phase 1 jobs report; Stakeholder outreach; and upcoming topics.

Commissioner Courtney thanked Ms. Kubick for her presentation.

GM Kelly responded to a question from Commissioner Courtney as to who will be conducting green infrastructure maintenance. Ms. Kubick responded to a follow-up question regarding green infrastructure certification. Brief discussion ensued. Commissioner Vietor noted the opportunities associated with green infrastructure and requested an update be agenized.

She outlined the auditors required communications and discussed auditor responsibilities under GASAS and GAS. She reviewed: (1) Reports issued; (2) Independence; (3) Significant accounting policies; (4) Management judgments and accounting estimates; (5) Audit adjustments; (6) No disagreements or difficulties with management; (7) No consultation with other accountants; No major issues discussed with management prior to retention; and (8) Material written communications.

Ms. Nicole Sandkulla, BAWSCA, introduced Tom Francis, BAWSCA's new Water Resources Manager. She expressed support for agenda item 12; provided comments on the Mountain Tunnel shut-down; discussed the Bay Delta Plan and substitute environmental document, reiterating BAWSCA's position on the Plan.
