CEQA Appeal Rights under Chapter 31 of the San Francisco Administrative Code: If the Commission's action on a project constitutes the Approval Action for that project (as defined in S.F. Administrative Code Chapter 31, as amended, Board of Supervisors Ordinance Number 161-13), then the CEQA determination prepared in support of that Approval Action is thereafter subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16. Typically, an appeal must be filed within 30 calendar days of the Approval Action for a project that has received an exemption or negative declaration pursuant to CEQA. For information on filing an appeal under Chapter 31, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call (415) 554-5184. If the Planning Department's Environmental Review Officer has deemed a project to be exempt from further environmental review, an exemption determination has been prepared and can be obtained on-line at http://www.sf-planning.org/index.aspx?page=3447. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or in written correspondence delivered to the Board of Supervisors, Planning Commission, Planning Department or San Francisco Public Utilities Commission at, or prior to, such hearing, or as part of the appeal hearing process on the CEQA decision.

All matters listed hereunder constitute a Consent Calendar, are considered to be routine by the San Francisco Public Utilities Commission and will be acted upon by a single vote of the Commission. There will be no separate discussion of these items unless a member of the Commission or the public so requests, in which event the matter will be removed from the Calendar and considered as a separate item.

- a) Approve Amendment No. 1 to <u>Agreement No. PRO.0043</u>, As-Needed Strategic Planning Services for the External Affairs Bureau and Divisions, with RDJ Enterprises, LLC, for continued strategic planning services for the External Affairs Bureau, increasing the agreement duration by two years, for a total agreement duration of five years, with no change to the agreement amount; and authorize the General Manager to execute this amendment. - b) Accept work performed by Western Water Constructors, Inc., for Contract No. WD-2548, Lake Merced Pump Station Essential Upgrades Project; approve Modification No. 18 (Final), decreasing the contract amount by \$121,493 for a total contract amount of \$35,954,987, and increasing the contract duration by 259 consecutive calendar days (approximately eight and one-half months) for a total contract duration of 3,484 consecutive calendar days (approximately nine years and seven months); and authorize final payment to the contractor.

- e) Approve an increase in the amount of \$500,000 to the existing contract cost contingency and an increase of 180 calendar days (six months) to the existing contract duration contingency for Contract No. WW-613, Southeast Water Pollution Control Plant Building 521/522 and Disinfection Upgrades; and authorize the General Manager to approve future modifications to the contract for a total contract amount of up to \$30,622,166 and a total contract duration of up to 1,489 consecutive calendar days (approximately four years and one month).
