



FY 2021-22 Residential High-Efficiency Clothes Washer Rebate Program

The SFPUC is offering a **\$100** rebate for the purchase and installation of a qualifying ENERGY STAR Most Efficient labeled high-efficiency clothes washer on the program's Qualifying Product List. This program applies to purchases from July 1, 2021- June 30, 2022.

IMPORTANT: PLEASE READ ALL PROGRAM RULES AND REBATE REQUIREMENTS BEFORE SUBMITTING YOUR APPLICATION. Note the details below before advancing to the application, as partial applications cannot be saved in our system.

Verify that your washer model is on our Qualifying Product List and that your washer was purchased within 60 days of this application. ***Applications for washers not on the list will be rejected.***

Have the following information ready:

- SFPUC Water Account and Account Holder/Name on Water Account
- Installation Address
- Applicant contact information (name, phone, email)
- Washer purchase information: purchase date, installation date, price, manufacturer, model number
- Itemized Proof of Payment as a PDF, JPEG, JPG, PNG, GIF, TIFF (Our system cannot accept HEIF attachments)
- Washer Retailer: email, phone, address, or website for online retailers

After completing your online application, send a completed and signed IRS Form W-9 to the San Francisco Controller's Office either by emailing them at supplier.management@sfgov.org OR mailing a hard copy your completed Form W-9 to: Supplier Management, 1 Dr. Carlton B Goodlett Place, Room 488, San Francisco, CA 94102. **Rebates cannot be issued without a W-9 form on file with the Controller's Office.**

Program Terms and Conditions for Participation

- To be eligible for the \$100 rebate, you must have an active SFPUC water account in good standing.
- The proof of payment submitted must indicate the itemized cost of the washer. Rebate amount will not exceed the purchase price of the clothes washer, not including taxes.
- Application submittal and W-9 must be completed within 60 days of purchase.
- A rebate check for qualifying product(s) is mailed twelve weeks after SFPUC receives and approves a completed application.
- An **IRS W -9 form** must be completed by all applicants to receive a rebate. The Social Security or Tax ID number requested in the Rebate application process is in compliance with exemptions to the Federal Privacy Act of 1974, 42 UCS 405 (c) (2)(c). Social Security numbers provided as part of the application process are held in confidence under terms of the Privacy Act.
- The approved washer must be installed at the SFPUC service address prior to rebate request. A separate application must be submitted for each metered address.
- You cannot receive multiple rebates for the same product.
- The washer must remain at the installation site for a minimum of six months after installation date.
- There is a limit of one rebate per household within a five-year period.
- The installation of qualifying clothes washers may not result in lower water bills.
- This program is subject to change or end without prior notice.

Rebate Agreement – Release of Liability

The SFPUC may deny any application that does not meet the requirements. The applicant agrees to allow the SFPUC to inspect washing machine installations as a condition to obtaining a rebate under this program. The SFPUC does not guarantee the performance of any washing machine or that the installation will be free of defects. The SFPUC also does not warrant the quality of the workmanship or suitability of the premises for the washing machine installation. The undersigned further agrees to hold blameless the SFPUC against loss, damage, expense, and liability resulting from the loss, destruction or damage of property arising out of or in any way connected with the installation of a washing machine. The SFPUC reserves the right to alter this program at any time. Funding for this program is limited to available resources. Rebates are processed on a first come, first serve basis and will only be processed until funds are depleted. Please allow up to 12 weeks for your completed application to be processed. Incomplete application cannot be processed.
