• The Committee discussed residents' concerns about groundwater. Staff Gillman explained that the most common concerns is water quality and taste. Staff Gillman explains that the amount of chemicals in water is well below the amount safely allowed by federal drinking standards. Also, wine and food critics from the Chronicle could not taste difference in a taste test.

- There was a question about environmental gentrification. Staff explained they do track displacement, and it has been increasing throughout the city. There are many contributing factors that are outside the purview of the agency. Many firm partners are working on neighborhood stabilization using their own money which could help reduce displacement.
- Member Clary expressed interest in using water affordability as an indicator in the Environmental Justice Analysis.
- There was indication that there will be an upcoming resolution which will encourage the use of local artists when commissioning artists for the public art as a part of the requirement in new construction.
- Member Ekanem again expressed his desire to have a master database where one can see all the construction being done in a certain area.
