



Geary Boulevard Sewer and Water Improvements Phase 2

Critical upgrades to our aging sewer and water infrastructure are planned for Geary Boulevard between 32nd Avenue and Stanyan Street



Who We Are

The San Francisco Public Utilities Commission (SFPUC) provides top quality drinking water and wastewater services to the city of San Francisco. To ensure a sustainable, safe, and seismically reliable water and sewer system now and for generations to come, we are continuously making upgrades to our water and sewer infrastructure.

Project Overview

Starting in early 2025, underground water and sewer pipes that have exceeded or are approaching the end of their useful life will be upgraded to maintain critical utility services, improve flows for firefighting, increase stormwater conveyance, and avoid disruptive emergency repairs. Most of this infrastructure is over 120 years old, dating back to the late-1800's when it was installed for the early development for the Richmond District.

This is the second phase of Geary Boulevard work. The first phase of improvements along the Geary corridor was completed in 2021. That phase rehabilitated or replaced approximately 2.5 miles of aging sewers and replaced approximately 5.8 miles of aging water lines along Geary Boulevard from 48th to 32nd avenues and from Presidio Avenue to Kearny Street. This second phase of work will bring these improvements to another stretch of the corridor.

Partnering Across City Agencies

We will be partnering with the SFMTA on this project. Upgrading our water and sewer pipes together with the SFMTA's planned transit and safety work minimizes disruption to the communities we serve. It also maximizes City resources by combining efforts into these large projects. We call this our 'dig once' approach.

Our joint goal is to minimize impacts and support neighborhood businesses as best we can during our work.

What to Expect During Construction

The project will be done in phases, so work will not be happening on your block for the entire project duration. Construction activity on your block will appear to be intermittent. Expect for crews to finish a portion of work on a block and then return at a later date (sometimes months later) to work on a different aspect of work.

- **SEWER SERVICE** in the area will NOT be interrupted.
- **WATER SERVICE** in the area will be temporarily interrupted when connecting the new water main to properties. Advance notice will be provided. Work may be performed at night to accommodate businesses which are affected by the temporary interruption of water service.
- **PARKING:** Parking may be temporarily prohibited in the work zone during construction. Crews will place “No Parking Signs” in impacted areas 72 hours in advance. Please pay attention to posted signs for exact workdays, hours, and locations, as they may vary.
- **TRAFFIC:** Partial lane closures may be necessary to ensure safety of workers and the public. Advance notice and signage will be provided.
- **ACCESS:** Businesses and residents in the work zone will maintain access to their entrances and driveways, although there may be temporary delays.
- **NIGHT AND WEEKEND WORK** may be required. Advance notice will be provided.
- **NOISE:** Neighbors should expect some noise during this work. The contractor will abide by the San Francisco Noise Ordinance.
