



Rain Barrel and Cistern Rebate Program

Property Owner's Notice and Release

Congratulations, your water-conscious tenant located at _____, is applying for the San Francisco Public Utilities Commission (SFPUC) **Rain Barrel and Cistern Rebate Program**. To help reduce potable water use for landscape irrigation, this program provides rebates on rain barrels or cisterns for SFPUC water service customers. Eligible participants can receive a \$100 discount on a rain barrel (limit 2), or a \$350 discount on a larger capacity cistern (limit 1).

Terms and Conditions

The undersigned Owner is participating in the SFPUC Rain Barrel and Cistern Rebate Program, under which SFPUC will provide a rebate for the purchase of up to two rain barrels or one cistern. Participants in the program agree to install and maintain the rainwater harvesting system according to the manufacturer's instructions and only use harvested rainwater for landscape irrigation.

Indemnification of City and County of San Francisco

I (Owner) hereby certify I am the legal owner of the property that is being served as a retail customer of the San Francisco Public Utilities Commission where rain barrel or cisterns will be installed. I agree that the SFPUC may inspect the installed rain barrel(s) or cistern; and that installation may not result in lower water bills; and that the SFPUC does not warrant any components included in the rain barrel(s) or cistern to be free of defects, the quality of workmanship, or the suitability of the premises for the rain barrel(s) or cistern.

THE INCENTIVES OFFERED UNDER THIS PROGRAM ARE INTENDED TO DEFRAID COSTS FOR IMPROVEMENTS AND HELP CUSTOMERS EFFICIENTLY USE RESOURCES. THE SFPUC DOES NOT GUARANTEE THE PERFORMANCE OR SUITABILITY OF ANY RAIN BARRELS OR CISTERNS OR THAT THE INSTALLATION WILL BE FREE OF DEFECTS. THE SFPUC ALSO DOES NOT WARRANT THE QUALITY OF THE WORKMANSHIP OR SUITABILITY OF THE PREMISES FOR THE INSTALLATION, WHICH OCCURS IN A SEPARATE TRANSACTION. SFPUC'S SOLE OBLIGATION TO THE CUSTOMER UPON APPROVAL OF THE REBATE APPLICATION UNDER THIS PROGRAM IS THE AMOUNT OF THE REBATE OFFERED. THE APPLICANT FURTHER AGREES TO RELEASE AND HOLD HARMLESS THE SFPUC FROM ANY LOSS, DAMAGE, EXPENSE, OR LIABILITY RESULTING FROM THE LOSS, DESTRUCTION OF, OR DAMAGE TO PROPERTY ARISING OUT OF OR IN ANY WAY CONNECTED WITH THE INSTALLATION OF RAIN BARREL(S) OR CISTERN.
