# Laundry-to-Landscape Graywater Rebate Program

## Property Owner's Notice and Release

Congratulations, your water-conscious tenant located at \_\_\_\_\_,

is applying for the **Laundry-to-Landscape Graywater Rebate Program**. Through the San Francisco Public Utilities Commission (SFPUC) program, eligible participants will receive a rebate for essential components of a laundry-to-landscape graywater system that diverts clothes washer water to the landscape for irrigation. Participants are eligible for a rebate up to \$100 for purchasing an inline vent, three-way valve, and PVC pipe and are required to complete an online installation training and receive a copy of the *Graywater Design Manual for Outdoor Irrigation* that provides step-by-step guidance on designing, installing and maintaining the laundry-to-landscape graywater system.

### **Terms and Conditions**

The undersigned Owner is participating in the SFPUC Laundry-to-Landscape Graywater Rebate Program, under which SFPUC will provide a rebate for the purchase of essential components of a laundry-to-landscape graywater system, a copy of the *Graywater Design Manual for Outdoor Irrigation*, and access to a program installation training on how to safely and properly install the kit on the Owner's property.

### **Indemnification of City and County of San Francisco**

I (Owner) hereby certify I am the legal owner of the property that is being served as a retail customer of the San Francisco Public Utilities Commission where the essential components will be installed. I agree that the SFPUC may inspect the installed essential components of a laundry-to-landscape graywater system; and that installation of this graywater system may not result in lower water bills; and that the SFPUC does not warrant any components included in the laundry-to-landscape kit to be free of defects, the quality of workmanship, or the suitability of the premises for laundry-to-landscape graywater installation kit.

THE INCENTIVES OFFERED UNDER THIS PROGRAM ARE INTENDED TO DEFRAY COSTS FOR IMPROVEMENTS AND HELP CUSTOMERS EFFICIENTLY USE RESOURCES. THE SFPUC DOES NOT GUARANTEE THE PERFORMANCE OR SUITABILITY OF ANY LAUNDRY TO LANDSCAPE ESSENTIAL COMPONENTS OR THAT THE INSTALLATION WILL BE FREE OF DEFECTS. THE SFPUC ALSO DOES NOT WARRANT THE QUALITY OF THE WORKMANSHIP OR SUITABILITY OF THE PREMISES FOR THE INSTALLATION, WHICH OCCURS IN A SEPARATE TRANSACTION. SFPUC'S SOLE OBLIGATION TO THE CUSTOMER UPON APPROVAL OF THE REBATE APPLICATION UNDER THIS PROGRAM IS THE AMOUNT OF THE REBATE OFFERED. THE APPLICANT FURTHER AGREES TO RELEASE AND HOLD HARMLESS THE SFPUC FROM ANY LOSS, DAMAGE, EXPENSE, OR LIABILITY RESULTING FROM THE LOSS, DESTRUCTION OF, OR DAMAGE TO PROPERTY ARISING OUT OF OR IN ANY WAY CONNECTED WITH THE INSTALLATION OF THE ESSENTIAL COMPONENTS.
