#### Topics of Discussion:

- The committee asked why the number of energy accounts is significantly higher than the water accounts. Amy explained that buildings will have one water meter but individual units within that building will have its own energy account.
- The committee asked about the CleanPowerSF messaging strategy. Amy explained they do post-call surveys for customers who opt out, the feedback has been mixed but the main concern is price.

- The committee asked what the price increase is from Green to SuperGreen for businesses. Amy informed that it is a 1.4%/KW premium over Green.
- The committee asked what the outreach plan is for the enrollment notices. Amy explained that they have a focused and targeted outreach for each phase i.e. mailing, advertising, contacting community groups. There were 50 signups through door-to-door outreach.
- The committee asked about marketing at large events such as concerts. Amy explained that large events are expensive to attend and that most people who attend are typically from out of town. Outreach at community events such as Sunday Streets have the most signups.

#### **Public Comment:**

 Michael Sizemore asked if multiple tenant office buildings break down the same way as residential units and if commercial tenants have rights to investigate the type of power your property manager purchases. Amy explained that energy in buildings depends on the metering and that CPUC would have more information on the rights of power.
