- Member Tang asked if there a way to publish the shut off schedule published by Cal ISO. This will allows customers can act proactively in case of a shut off.
 - **Staff Gollatta** answered that the Department of Emergency Management will schedule AlertSF messages regarding power shut offs to those who are signed up for AlertSF.
- Member McHugh asked if there any joint planning on communications with PG&E in the event of power outages.
 Staff Gollatta replied our goal is to better understand what PG&E will do since they don't provide much advance notice on power outages and how we can plan accordingly in partnership.
