

# Sewer Upgrades Project

### **Coming Soon in Your Area**

As part of the Sewer System Improvement Program, the San Francisco Public Utilities Commission (SFPUC) contractor, Cratus Inc., will begin construction to rehabilitate the existing 100-year-old sewer pipelines and replace some manholes and sewer laterals on Commercial Street, between Grant Avenue and Montgomery Street.

2023 Project Schedule: Commercial Street (Subject to Change)

General Work Hours: Monday-Friday at 8:00am - 5:00pm

- Week of February 13: Inspection and pre-cleaning of sewers
- Week of March 20: Crews will begin upgrading manholes
- . Months of April and May: Construction and sewer upgrades continue
- Mid-June: Sewer upgrades (open-cut sewer excavation)
- Month of August: Crews will return to finish the work and pave the street


\*Additional notice will be provided prior to major construction in April-May. Weather and construction issues could impact the schedule. Expect delays, consider alternate routes, and plan ahead if you must travel through the area.

#### What to expect:

- SEWER SERVICE: These services will NOT be interrupted during construction.
- **PARKING:** Street parking will be impacted near construction zones. "Noparking" signs will be posted 72 hours in advance.
- TRAFFIC: Partial and/or full lane closures may be necessary to ensure safety of workers and the public. Advance notice and detour signage will be provided, as needed.
- MUNI: Bus stops may be impacted during work, and if so, advance notice will be provided.
- ACCESS: Follow posted signage on site. Businesses and residents in the work zone will maintain access to their driveways and entrances during construction.
- NOISE: Neighbors may hear construction noise periodically. Noisy work will be conducted in compliance with the San Francisco Noise Ordinance.
- ODORS: If necessary, odor control measures will be in place during construction.
- NOTICE: Expect to receive regular email updates from the project team.


